

Instructions for completing the Lease Application

Applicants must complete **all applicable fields** on the lease application as well as the Pre-Authorized Debit (PAD) Agreement. If there is more than one person who will be living there and paying rent, please complete the section for Tenant (2). If they will not be paying rent, but living there, please write (Occupant) beside their name. This also applies to minors.

Please include the following with your application and completed PAD Agreement:

- 1. A clear photocopy of your driver's license. If you do not have a driver's license, please include a photocopy of another valid government issued photo ID.
- A cheque for half the rent (before any discount and not including parking or locker charges; please see the application form) as a Security Deposit, made payable to 3346234 Manitoba Ltd. If your banking institution does not issue cheques, payment for the Security Deposit may be made by Money Order/Bank Draft.
- 3. **A cheque marked "VOID"** to be attached to the PAD Agreement. In place of the VOID cheque you may provide a printout from your bank with your bank account details (institution number, transit number, and account number are required).
- 4. Letters of employment or landlord reference letters. These will help expedite the process.
